

Spending at the state level is calculus, not simple math as some people think. To be clear, I am opposed to increasing taxes and fees. Each cylo of spending (ex: Education, Healthcare, Transportation, ect.) has a character of its own. Most times, when you pull a lever in one corner of the budget, it can and usually causes a reaction in more than just one place elsewhere in the budget. FL, due to its Constitution, must balance our budget every year. So, as a business owner, this question must always be answered, "how do we balance the budget, without increasing taxes or fees, and deliver the most efficient government to the citizens of Florida.

What do you believe are the main issues facing the State of Florida? *

The defense and protection of Faith, Family, Freedom, Opportunity and Life. The reason that these issues are so important is that they form the foundation of how Florida society should operate for the best long-term results. When situational emotion drives the agenda, instead of concrete principles, we can easily veer off course for the long haul. Look around the country at how places like Portland and San Francisco have made these types of mistakes and the terrible consequences they are suffering, even today. We need steady, principled hands on the wheel.

What is your opinion on government providing incentives to businesses? *

I am certainly supportive of business incentives as long as they are accountable, transparent and do not evolve into long-term business welfare or subsidies. The free market should be allowed to influence our economy as much as possible, but this doesn't always work; at that point we should begin the disussion about incentives to support job creation and economic growth.

How can the City of Lakeland help attract and retain a vibrant and talented workforce? *

I would suggest this specific answer should be left up to the elected leadership for the City of Lakeland in partnership with Lakeland businesses. I'm always interested in listening/talking about these issues to see where the intersection of State and Local can produce better results. Keep in mind that there are hundreds of municipalities in FL who have varying perspectives of how to solve the problem. The common sense basics of training and education seem to always rise to the top of the list though.
